## GLOBAL CENSORSHIP YOUTUBE STARTS REMOVING CONTENT ON ELECTION FRAUD

**Experts describe move as unprecedented, expect similar policies could be adopted by other social media platforms such as Facebook and Twitter**

YouTube announced on Dec. 9 that the company will immediately start removing content pertaining to alleged “widespread fraud or errors” that took place in this year’s

presidential election, a move that experts say is unprecedented in its scope and warned such censorship could trickle into every other major platform.

In a statement, the video-sharing platform said it will begin “enforcing this policy today, and will ramp up in the weeks to come.” The company said news coverage and commentary on these issues “can remain on our site if there’s sufficient education, documentary, scientific, or artistic context.”

The company, which is owned by Google, didn’t provide additional context but offered an example, saying, “We will remove videos claiming that a Presidential candidate won the election due to widespread software glitches or counting errors.”

The reason YouTube gave for the change is that the Dec. 8 “safe-harbor deadline” for the U.S. Presidential election” had passed, and that “enough states have certified their election results to determine a President- elect.”

## **Expert identifies 200,000 votes hijacked from Trump to Biden in Georgia at the precinct level**

Data Expert Edward Solomon analyzed the 2020 election results in Georgia and identified another pattern in the data showing ultimately 200,000 votes transferred from President Trump to Joe Biden at the precinct level.

President Trump was reportedly ahead in the 2020 election in Georgia on Election night by over 100,000 votes. But within hours his lead was diminished. It’s likely even when President Trump was hundreds of thousands of votes ahead, he had already had 200,000 votes (net) moved from his totals to Joe Biden.

Then when this was not enough to steal the election for Biden, the Democrats implemented emergency measures in Atlanta, making up a water main break story in an effort to vacate the State Farm Center where absentee ballots were being counted. Once alone, a few individuals stuck around and pulled suitcases full of ballots out from under a table and added thousands of ballots for Joe Biden to the system. Eventually the election was stolen for Biden in Georgia by 10,000 votes.

# Texas sues Georgia, Michigan, Pennsylvania and Wisconsin for election fraud; EIGHT states join the lawsuit

(Natural News) The Republic of Texas just released the “kraken” against the states of Georgia, Michigan, Pennsylvania and Wisconsin, all of which produced fraudulent, and thus invalid, election results.

**Update:** Seventeen additional states are reportedly joining the Texas lawsuit including: Louisiana, Arkansas, Alabama, Florida, Kentucky, Mississippi, South Carolina, South Dakota.

**The Lone Star State is arguing that all of these states violated the Electors Clause of the Constitution by illegally changing their voting rules and procedures through courts or executive actions rather than lawfully through state legislatures. These states also violated the Equal Protection Clause of the Constitution by implementing different voting rules and procedures in different**

**areas within their own state borders, according to the lawsuit.**

Last but not least, the lawsuit alleges that the aforementioned constitutional violations led to “voting irregularities” that resulted in fraudulent election results, which must be overturned in the interest of preserving free and fair elections in the United States.

“Certain officials in the Defendant States presented the pandemic as the justification for ignoring state laws regarding absentee and mail-in voting,” the lawsuit reads. “The Defendant States flooded their citizenry with tens of millions of ballot applications and ballots in derogation of statutory controls as to how they are lawfully received, evaluated, and counted.”

“Whether well intentioned or not, these unconstitutional acts had the same uniform effect – they made the 2020 election less secure in the Defendant States,” it adds. “Those changes are inconsistent with relevant state laws and were made by non-legislative entities, without any consent by the state legislatures. The acts of these officials thus directly violated the Constitution.”
