CHILDRENS VACCINATION WITHOUT PARENTAL CONSENT

The District of Columbia Municipal Regulations Washington D.C. Hearing on June 26th:

B23-0171 would add a new section into the existing District of Columbia Municipal Regulations that would allow a minor child of any age to consent to receive a vaccine where the minor is capable of meeting the informed consent standard and where the vaccination is recommended by the US Advisory Committee on Immunization Practices.

According to this proposal, a minor shall be deemed meeting the informed consent standard if the minor is able to comprehend the need for, the nature of, and any significant risks ordinarily inherent in the medical care.

B23-0171 eliminates parental rights by removing the requirement that vaccine administrators obtain the voluntary, informed consent of a minor child's parent in order for the child to be vaccinated. B23-0171 blatantly ignores the existing intent of other laws and regulations putting parents in charge of vaccination decisions including section providing the legal right of the parent to claim a medical or religious exemption to vaccination.

B23-0171 places vaccines in a special category to allow legally unaccountable individuals to persuade a minor child to get vaccinated without the knowledge or consent of the parent.

Unlike medical, school or other personnel administering vaccines, parents are legally accountable and financially responsible for the health care and education of a minor child when that child experiences a vaccine reaction and becomes chronically ill or disabled.

Vaccines are pharmaceutical products that carry a risk of injury or death. The U.S. federal Vaccine Injury Compensation Program has awarded more than 44 billion to vaccine victims since 1988 but two of three vaccine injured plaintiffs are turned away without financial support.

Both the National Childhood Vaccine Injury Act of 1986 and U.S. Supreme Court Decision (Bruesewitz v. Wyeth) guarantee that vaccine manufacturers, doctors and other vaccine administrators have no legal accountability or financial liability in civil court when a government recommended or mandated vaccine(s) causes permanent injury or death.



By consenting to a vaccine, a child alone is acknowledging that they have abdicated their constitutional right to a trial by jury should they become injured.

Also, this one-sided proposal actually fails at implementing informed consent rights for the child because it does not equally permit a child to use their same application of their comprehension of risks and benefits to refuse a vaccine their parents have previously chosen for their child to receive.

The legal right of parents to give their informed consent for minor children to take medical risks, which can result in injury or death, trumps the goals of health agencies or vaccine corporations and medical organizations, whose employees, stockholders or members profit or professionally benefit from increased, widespread vaccine use.

I STAND WITH ISRAEL FOLAU

So much for tolerance!There are three questions I want to ask with regards to Israel Folau losing his job over his Christian views:

- 1. is Israel speaking the truth?
- 2. does he have the right to say it?
- 3. do we need to hear his message?

1. Is Israel Folau speaking the truth?

Israel posted a meme on his personal Instagram page with a vital message from the most loved and bestselling book across the world and across millennia. He didn't do this to judge, but because he doesn't want anyone to miss out on making heaven.

To every commentator who has derided Israel's theology, I want to ask this question: *what's your evidence for stating that Israel Folau is wrong?*

When anyone asks the question: 'what will happen to me after I die', there is one source we can turn to for a trustworthy answer, the Bible. So which critic of Israel Folau can fault his theology from the Word of God?

Whether we consider the story of origins in Genesis as historical or metaphorical, the message of the Garden of Eden is the same: we have all sinned against almighty God. As a result, humankind has been expelled from the perfection of God's garden and the way back is blocked, bar one solution.

In truth, we are all an 'Adam' or an 'Eve' because we all face the same choice: will we take the sustenance of life from the Word of God, or will we, like Frank Sinatra sang, do it my way? This choice is represented in the Bible by the metaphorically named Tree of Life and the Tree of the Knowledge of Good and Evil.

From the beginning God has warned us that going our own way will result in death:

Then the Lord God said, "Look, the human beings have become like us, knowing both good and evil. What if they reach out, take fruit from the tree of life, and eat it? Then they will live forever!" So the Lord God banished them from the Garden of Eden, and he sent Adam out to cultivate the ground from which he had been made. After sending them out, the Lord God stationed mighty cherubim to the east of the Garden of Eden. And he placed a flaming sword that flashed back and forth to guard the way to the tree of life. (Genesis 3:22-24 NLT).

We have all sinned against God and we can't redeem ourselves. That's why we need a saviour...

For everyone has sinned; we all fall short of God's glorious standard. Yet God, in his grace, freely makes us right in his sight. He did this through Christ Jesus when he freed us from the penalty for our sins. For God presented Jesus as the sacrifice for sin. People are made right with God when they believe that Jesus sacrificed his life, shedding his blood. (Romans 3:23-25 NLT)

2. Does Israel Folau have the right to say it?

Israel Folau posted a meme on his personal Instagram account on the 10th

April 2019. His message was a warning to various types of people that "HELL AWAITS YOU, REPENT! ONLY JESUS SAVES". This meme was widely quoted by the media, but little has been said about the full social media post which also stated: "Those that are living in sin will end up in Hell unless you repent. God loves you and is giving you time to turn away from your sin and come to him."

Israel Folau then quoted three complete Bible verses:

"Now the works of the flesh are manifest, which are these; adultery, fornication, uncleanness, lasciviousness, idolatry, witchcraft, hatred, variance, emulations, wrath, strife, seditions, heresies, envyings, murders, drunkenness, revelings, and such like: of the which I tell you before, as I have also told you in time past, that they which do such things shall not inherit the kingdom of God." (Galatians 5:19-21 King James Version).

And here are the words of Jesus that command us to shout his message from the housetops:

What I tell you now in the darkness, shout abroad when daybreak comes. What I whisper in your ear, shout from the housetops for all to hear! "Don't be afraid of those who want to kill your body; they cannot touch your soul. Fear only God, who can destroy both soul and body in hell. (Matthew 10:27-28 NLT).

3. Do we need to hear Israel Folau's message?

With 100% certainty, yes. Let's look at some of the commandments not to sin...

Have you ever lied? Have you ever stolen? Have you ever failed to love someone? Are we not all sinners before God and in need of his way of redemption?

For those who have no faith in the Bible, this may not seem important right now. But when your number comes up, and you don't know when that will be, you won't be able to say to God that you weren't warned!

For the scriptures tell us that when we die our destination can only be either heaven or hell - as will be determined as we give account to God of how we have lived our lives (Romans 14:11-12).

For we can't avoid this reality... upon death no one can take even one sin into the perfection of heaven. Would you want heaven any other way?

So, Israel Folau has done us a huge favour by counselling us to carefully consider our position before God, to accept his love for us and to seek his plan of salvation that will keep us out of hell:

"For this is how God loved the world: He gave his one and only Son, so that everyone who believes in him will not perish but have eternal life. God sent his Son into the world not to judge the world, but to save the world through him. "There is no judgment against anyone who believes in him. But anyone who does not believe in him has already been judged for not believing in God's one and only Son. (John 3:16-18 NLT).

I stand with Israel Folau, I can do none other.

Call to Action

It's time to take a stand for Freedom of Speech and Freedom of Religion.

The Instagram post of Israel Folau has impacted the nation for good beyond Israel's wildest imagination. For example, freedom of speech and freedom or religion became major factors in the 2019 Federal election campaign and caused the nation to ask the question: what right does an employer have to take away our freedoms when we're away from work?

Israel Folau has stated publicly that he did not sign any contract that would deny him the capacity to express his belief when away from work. While we can't comment on this because of impending legal action, we can and should write to or visit our Members of Parliament to emphasise the importance to us of the preservation of our freedoms.

The very real concern of many experts on the impending legislation on freedom of religion is this:

Do we just want fragile exemptions from other anti-discrimination laws, or do we want to see our freedoms enshrined as positive rights for all Australians?
