## Trump taking controversial drug after Hasidic doctor recommended it

**President Donald Trump said Monday that he is taking hydroxychloroquine, the controversial antimalarial drug whose use to combat COVID-19 has been touted heavily by a Hasidic doctor in upstate New York.**

The doctor, Vladimir Zelenko, who has expressed support for Trump on social media, sent a letter to the White House in March about his initial results in using the drug to treat presumptive Covid cases on an outpatient basis. Speaking to

reporters after a meeting with restaurant executives at the White House Monday, the president said that he had begun taking the drug after receiving a letter from a New York doctor who was treating his patients with it, though he did not name the doctor.

“He didn't want anything,” Trump said of the doctor. “He just said, 'Sir, I got hundreds of patients and I give them hydroxychloroquine, I give them the Z-pak, which is azithromycin, and I give them zinc. And out of the hundreds of patients, many hundreds of patients, I haven't lost one.' He said, 'Please keep pressing that, sir.'”

Trump said he is taking hydroxychloroquine and a zinc supplement, though not the antibiotic azithromycin.

**Dear President Trump:**

I humbly offer the following observations:

1. Based on my front-line experience, it is essential to start treatment against Covid-19 immediately upon clinical diagnosis of the infection and not to wait for confirmatory testing. There is a very narrow window of opportunity to eliminate the virus before pulmonary complications begin. Delaying treatment is the essence of the problem. My treatment regime is listed below and please know that as of today it has saved 383 patients without complications or negative side effects.

2. Based on my front-line experience, the emphasis must be on preemptive treatment for high-risk patients in the outpatient setting - primary care and urgent care settings. It makes no sense to wait until a patient is admitted to a hospital and put on a ventilator. High-risk patients are those over the age of 60, those with underlying health conditions or compromised immune systems, and anyone with symptoms and shortness of breath.

In addition, we should consider immediate prophylactic treatment of very high-risk individuals. Very high-risk individuals are front-line health care providers, nursing home residents, police officers, etc.

3. Based on my direct observations, the risk of side effects to this treatment regime is exaggerated. The theoretical risk of heart arrhythmia (QT prolongation) is 1 in a 1000. However, the actual risk of death from Covid-19 in the high-risk population is between 5 to 10%. The risk versus benefit analysis overwhelmingly favors treatment. And in my clinical experience, I have seen no negative side effects.

4. This is World War III (virus vs humanity). Under these circumstances, we don't have the luxury of operating as we do in peacetime. Waiting for the results of clinical trials while people are dying is unethical. Millions will die and the economy will collapse while we wait.

5. My field-tested treatment regimen for high risk patients with clinical diagnosis is as follows:

- Hydroxychloroquine 200mg twice a day for 5 days
- Azithromycin 500mg once a day for 5 days
- Zinc sulfate 220mg (or the equivalent of 50mg elemental zinc) once a day for 5 days

6. I also suggest the following prophylactic regimen for very high risk individuals:

- Hydroxychloroquine 200mg once a day for 5 days, and then 1 pill a week until immunity can be shown or a vaccine becomes available.
- Zinc Sulfate 220mg (or the equivalent of 50mg elemental zinc) once a day for 5 days, and then 1 pill a week until immunity can be shown or a vaccine becomes available.

**Dear Mr. President:**

I humbly request the following:

1. We need an executive order to override any state obstacles and to (a) allow all physicians to prescribe the above regime without the fear of liability or retribution; and (b) permit pharmacies to dispense this medication without the fear of liability or retribution.

2. The pharmacies need an immediate supply of sufficient medicine to dispense the above regime to at least 15 million people. Please do everything in your power to achieve this.

3. The Task Force should give permission to physicians to treat their patients early and aggressively based on clinical diagnosis, without the delay caused by confirmatory testing. (Of course, if tests results come back negative, then the patient should be advised to stop the

medication.)

4. Any bureaucratic/man made obstacles that interfere with doctors' ability to treat their patients with these well known, field tested, inexpensive and life saving medications in my humble opinion is inexcusable and should be treated as a crime against humanity. <END>

# Hydroxychloroquine rated 'most effective therapy' by doctors for coronavirus

An international poll of more than 6,000 doctors released Thursday found that the antimalarial drug hydroxychloroquine was the most highly rated treatment for the novel coronavirus.

[The survey](#) conducted by Sermo, a global health care polling company, of 6,227 physicians in 30 countries found that 37% of those treating COVID-19 patients rated hydroxychloroquine as the "most effective therapy" from a list of 15 options.

Of the physicians surveyed, 3,308 said they had either ordered a COVID-19 test or been involved in caring for a coronavirus patient, and 2,171 of those responded to the question

asking which medications were most effective.

The U.S. Food and Drug Administration gave chloroquine and its next-generation derivative, hydroxychloroquine, emergency-use authorization Monday for treating the novel coronavirus, although the drug was already being used off-label by some doctors and hospitals for COVID-19 patients.

The survey also found that the most commonly prescribed treatments are analgesics (56%), azithromycin (41%) and hydroxychloroquine (33%).

Azithromycin, known by the brand name Zithromax or Z-Pak, was rated the second-most effective therapy at 32%, followed by "nothing," analgesics (including acetaminophen), anti-HIV drugs and cough medicine.

Hydroxychloroquine, which is sold under the brand name Plaquenil, was prescribed mainly in the United States for the most severe cases, but not so in other countries.

"Outside the U.S., hydroxychloroquine was equally used for diagnosed patients with mild to severe symptoms whereas in the U.S. it was most commonly used for high risk diagnosed patients," the survey found.

The 30 nations surveyed included those in Europe, Asia, North America and South America, as well as Australia. No incentives were provided to participate in the poll, conducted March 25-27, according to Sermo.
