quality control of the safety and efficacy of vaccines for 32 years. Neither the US government nor the Australian government have provided reports/studies showing evidence of safety of vaccines during this time. This has wide ramifications for the Australian government's coercive vaccination policies. This is a document that can support any legal action to make the government accountable for the lies that have been told to parents about vaccine safety and efficacy for over 32 years.

Since January 2016 coercive vaccination policies have been introduced into Australia that require children and some adults to have up to 16 vaccines to attend preschools/childcare centres (for 0-5 yr olds), for adults in employment situations and for university students in some fields of study.

Prior to 2016 all vaccines were a voluntary choice in Australia and they have never been used to control these diseases. They are also not proven to prevent these diseases as evidenced by the many vaccinated children/adults that are still getting these diseases. Further, there was no increased risk from these diseases when the government mandated up to 16 vaccines in 2016 for parents to receive welfare benefits and the government has refused under the Freedom of Information Act to release the advice that the Chief Medical Officer Relied on to implement coercive vaccination policies.

As of 1 May 2020 the Australian government is using coercive measures to promote the flu vaccine for some adults and children. This is being done under its COVID19 emergency powers that were requested in January 2020. Australians can take legal action to protect their fundamental right to bodily integrity by requesting that the employer or administrator signs this form to accept liability for any harm or ill health/death that is caused from this injection. If the employer/administrator will not accept liability then there is no requirement for you to have the vaccine.

#### **Queensland Health**

The Queensland Government's **Age Care Direction (No. 9)** can be seen on <u>this link.</u>

The "Direction" was posted and became effective on 11 August 2020.

On 29 January 2020, under the Public Health Act 2005, the Minister for Health and Minister for Ambulance Services made an order declaring a public health emergency in relation to coronavirus disease (COVID-19). The public health emergency area specified in the order is for 'all of Queensland'. Its duration has been extended by regulation to 2 October 2020 and may be further extended.

Further to this declaration, l, Dr Jeannette Young, Chief Health Officer, reasonably believe it is necessary to give the following directions pursuant to s362B of the Public Health Act 2005 to assist in containing, or to respond to, the spread of COVID-19 within the community.

#### PART 1 — REQUIREMENTS FOR ALL RESIDENTIAL AGED CARE FACILITIES

 This part applies to all residential aged care facilities in the State of Queensland.

- 6. A person must not enter, or remain on, the premises of a residential aged care facility in the State of Queensland from the time of publication of this direction until the end of the declared public health emergency if: [Note 6.e.]
  - a. during the 14 days immediately preceding the entry, the person arrived in Australia from a place outside Australia; or
  - b. during the 14 days immediately preceding the entry, the person has been in a <u>COVID-19 hotspot</u>; or
  - c. during the 14 days immediately preceding the entry, the person had known contact with a person who has a confirmed case of COVID-19; or
  - d. the person has a temperature equal to or higher than 37.5 degrees or symptoms of acute respiratory infection; or
  - e. the person does not have an up to date vaccination against influenza, if the vaccination is available to the person.

Example – the vaccination is not available to a person with a medical contraindication to the influenza vaccine.

#### **Reasonable interpretation:**

A person without up to date vaccination against influenza can not enter, an Aged Care facility, if the vaccination is available to the person but vaccination is not available to a person with a medical contraindication to vaccination. Contraindication is not defined in the Act nor the Aged Care Direction and the medical condition which is private information and disclosure requires consent.

#### In related news.

The Australian Prime Minister, Scott Morrison, during a television evening news on Friday evening Aug 21st revealed that, a "COVID-19 hotspot" is undefined.

## CONDITIONAL ACCEPTANCE OF VACCINATION -- AGREEMENT BETWEEN VACCINE PROVIDERS AND VACCINATED PARTY -

As manufacturers of vaccines can't be sued for damages caused by their vaccinations it is the responsibility of the person to establish liability with the vaccinators. This document defines your conditional acceptance.
