PLEASE FAMILIARISE YOURSELF WITH THE FOLLOWING POINTS

- **1**. People who have a medical condition DO NOT have to wear masks.
- **2. You DO NOT need a medical certificate** stating you do not need to ware a mask.
- **3.** Employees who are medically exempt cannot be forced to wear a mask.
- **4. Business owners are NOT responsible** for people who cannot wear masks.
- **5.** Medically exempt conditions include Asthma, Emphysema, Epilepsy, ADHA, PTSD, Anxiety, Panic Disorders, Vertigo, Hearing Problems, Breathing Difficulties, Allergies, as such & many more...
- 6. No one is required to tell you, or disclose their personal medical information to anyone.

- **8.** Signs saying '**No Mask No Entry**' are in breach of section 6 & 24 of the Commonwealth Discrimination Act 1992 (and other laws) and should either be removed from premises or state 'EXCEPT THOSE WITH LAWFUL MEDICAL CONDITIONS' or a similar disclaimer.

- **9.** Harassment, intimidation, coercion, deceit, aggressiveness or bullying are NOT lawful means of imposing your personal beliefs or opinions about masks on upon others.
- 10. Many people medically exempt from wearing masks including the majority of senior citizens, even though they may not be currently aware of their exemptions.
