Australian Member of Parliament, Tanya Davis reads portions of a ruling handed down on Monday Sept 27, 2021 by the Fair Works Commission.



"It's in relation to an appeal Lodged by an aged care worker who was sacked from a job because she refused to have a flu vaccine and that works appealed that that decision of the fair work commission to indorse it." ... "Now I know that that was talking about a flu vaccine but ... Part 2 [of the report] is where the action really happens for us who are fighting the mandatory vaccination policy of the government or lose your job. So, part 2 is headed"

PART 2 - VACCINE
REQUIREMENTS IN RELATION TO
COVID [101]

N.B. Tanya refers to page numbers in the document, but these are not displayed in the online file linked to below but the paragraphs are numbered. So, her reference to Part 2 on page 32 refers to text from numbered paragraph [101] and beyond, in the online document.

"Now it goes from page 32 to page 44 and it is, pretty... pretty shocking, in terms of what this Fair Work Commission has determined in relation to the settings around, that vaccination should be voluntary. Around the hesitancy of people having the COVID vaccine. Around the use of Public Health Orders [PHO] to mandate vaccination coverage..."

[106] On 13 August 2021, the Australian council of trade unions and the Business Council of Australia, they



issued a joint statement on mandatory COVID vaccinations in which it acknowledged, that the Australian Government's COVID vaccination policy, that the vaccine is voluntary and confirmed the views of the BCA and the ACTU that for the overwhelming majority of Australians your work, or workplace, should not fundamentally alter the voluntary nature of vaccination.

[107] The Fair Work ombudsman has also come out and said that the majority, overwhelming majority of employers, should assume they can't require employees to be vaccinated against coronavirus.

[108] Safe Work Australia has publicly stated that most employers will not need make vaccinations mandatory in order to meet health and safety obligations.

"And it gets more and more interesting. Mandatory COVID vaccinations - this is a thing that we're all fighting against - however cannot be justified in almost every workplace in Australia. While there are a number of reasons for this, this decision that is a decision in this document."

"We'll focus on three things, the requirement for free, freely given and informed consent for medical procedures. Denying an unvaccinated person, the ability to work on health and safety grounds, whether at the initiation of an employer or as part of a public health order and the

requirements to comply with disability discrimination laws."

"Now what's interesting is that this Fair Work Commission decision has actually identified a couple of things that you have all been talking to me about, but which I have been a little bit reluctant to say publicly on this [Facebook] channel, but I'm reading the words from the Fair Work Commission.

[113] Before turning to a consideration of these reasons of I've just mentioned above it is important to set the context with some information that is publicly available and should be un-controversial.

- a. Unlike many other vaccinations such as those used to stop the spread of tetanus yellow fever and smallpox, COVID vaccinations are not designed to stop COVID. They are designed to reduce the symptoms of the virus. However, a fully vaccinated person can still contract and transmit COVID.
- b. The science is clear in that COVID is less serious for those who are young and otherwise healthy, compared to those who are elderly or have comorbidities ...
- c. "The World Health
 Organization has stated that most
 people diagnosed with COVID will
 recover without the need for any
 medical treatment.
- d. The vaccines are only provisionally approved for use in Australia and are accordingly still part of a clinical trial.

e. There are side effects to the COVID vaccines that are now known. That side effect exists is not a conspiracy theory." [Video 5:56] f. The long-term effects of the COVID vaccines are unknown and this is recognised by the Therapeutic Goods Administration in Australia.

[114] Consent is required for participation in clinical trials... It is legally, ethically and morally wrong to coerce a person to participate in a clinical trial.

"So, the Fair Work Commission has identified that the COVID vaccines are actually part of the clinical trial and they go into a lot of detail around the requirements; the legal and the internationally binding requirements that a participant in a clinical trial must provide consent and what does that consent entail."

"I... again I won't go into any of the details but again I urge you to please read this document because it is monumental to people who are fighting the forced vaccination public health orders of this State.

"There's a point here on page 35. Can COVID vaccinations be mandated by employers on health and safety grounds? [130] The short answer to this question, in almost every case, is no." [Video 7:14]

"Well, that's a decisive decision for you. Let me go over, it says; Critically there is another alternative to vaccines to assist employers in meeting their work health and safety obligations and that is being tested actually the rapid antigen testing or other tests PCR tests which many of us have had testing is arguably a better control measure compared to vaccines in meeting health and safety obligations because you pretty much can determine if someone has the virus or doesn't have the virus with the test, whereas, we already know that those who are vaccinated can still carry the virus.

In short there is no justifiable basis for employers to mandate COVID vaccinations to meet their health and safety obligations, when there are other options available to appropriately manage the risk."

"Now it goes on again it goes on to more and more evidence that backs up our fight against mandatory vaccinations or people will lose their job."

"Alright. But let me now turn to the final comments. Now their final comments [are] powerful, absolutely powerful and if you don't read anything else in this report then turn to page 41 and read the comments under the heading called Final Comments."

Final comments

[179] Research in the context of COVID-19 has shown that many who are 'vaccine-hesitant' are well educated, work in the health care industry and have questions about how effective the vaccines are in stopping transmission, whether they

are safe to take during pregnancy, or if they effect fertility. A far safer and more democratic approach to addressing vaccine hesitancy, and therefore increasing voluntary vaccination uptake, lies in better education, addressing specific and often legitimate concerns that people may hold, and promoting genuine informed consent. It does not lie in censoring differing opinions or removing rights and civil liberties that are fundamental in a democratic nation. It certainly does not lie in the use of highly coercive, undemocratic and unethical mandates.

[180] The statements by politicians that those who are not vaccinated are a threat to public health and should be "locked out of society" and denied the ability to work are not measures to protect public health. They are not about public health and not justified because they do not address the actual risk of COVID. These measures can only be about punishing those who choose not to be vaccinated. If the purpose of the PHOs is genuinely to reduce the spread of COVID, there is no basis for locking out people who do not have COVID, which is easily established by a rapid antigen test. Conversely, a vaccinated person who contracts COVID should be required to isolate until such time as they have recovered.

[181] Blanket rules, such as mandating vaccinations for everyone across a whole profession or industry regardless of the actual risk, fail the tests of proportionality, necessity and reasonableness. It is more than the absolute minimum necessary to combat the crisis and cannot be justified on health grounds. It is a lazy and fundamentally flawed approach to risk management and should be soundly rejected by courts when challenged.

[182] All Australians should vigorously oppose the introduction of a system of medical apartheid and segregation in Australia. It is an abhorrent concept and is morally and ethically wrong, and the anthesis of our democratic way of life and everything we value.

[183] Australians should also vigorously oppose the ongoing censorship of any views that question the current policies regarding COVID. Science is no longer science if it a person is not allowed to question it.

[184] Finally, all Australians, including those who hold or are suspected of holding "antivaccination sentiments", are entitled to the protection of our laws, including the protections afforded by the Fair Work Act. In this regard, one can only hope that the Majority Decision is recognised as an anomaly and not followed by others.
